WRITTEN DESCRIPTION OF AHSTW CSD DIRECTOR DISTRICTS – EFFECTIVE JULY 1, 2023

Director District 1: All of the area within the school district in Harrison County; all of the area within the school district in Cass Township, Shelby County; all of the area within the school district in Shelby Township, Shelby County that is west of a line beginning at the north school district boundary and the east 2020 corporate limits of the city of Tennant: thence south along the corporate limits to Road F 58, thence westerly along Road F 58 to Road M 16, thence southerly along Road M 16 to the north 2020 corporate limits of the city of Shelby, thence easterly and southerly along the corporate limits to the south township line (also the south Shelby County line), includes the city of Shelby (2020 corporate limits) including the portion of the city of Shelby in Pottawattamie County, also includes the portion of the city of Tennant that is within the school district.

Director District 2: All of the area within the school district in Lincoln Township, Shelby County; all of the area within he school district in Shelby Township, Shelby County that is not included in Director District 1; all of the area within the school district in Fairview Township, Shelby County; all of the area within the school district in Minden Township, Pottawattamie County; all of the area within Pleasant township, Pottawattamie County not including any portion of the city of Shelby (2020 corporate limits); all of the area within Knox Township, Pottawattamie County that is west of a line beginning at the north township line (also the north County line) and the West Nishnabotna River: thence southerly along the W Nishnabotna River until it intersects with the west 2020 corporate limits of the city of Avoca, thence southerly then easterly along the corporate limits to its intersection with U.S. Highway 59; thence southerly along U.S. Highway 59 to the south township line; all of the area within the school district in York Township, James Township and Valley Township, Pottawattamie County including the city of Hancock.

Director District 3: All of the area within Knox Township, Pottawattamie County and within the city of Avoca (2020 corporate limits) that is bounded by a line beginning at the north township line (also the north County line) and the West Nishnabotna River: thence southerly along the W Nishnabotna River until it intersects with the west 2020 corporate limits of the city of Avoca, thence southerly along the corporate limits to its intersection with W High Street, thence easterly along W High Street to N Pine Street, thence northerly along N Pine Street to W Wool Street, thence easterly along Wool Street to N Walnut Street, thence northerly along N Walnut Street to W Thomas Street, thence easterly along W Thomas Street to E Thomas Street, thence continuing easterly along E Thomas Street to the east corporate limits of the city of Avoca, thence northerly along the corporate limits to the north township line (also the north County line), thence westerly along the township line to the point of beginning.

Director District 4: All of the area within Knox Township, Pottawattamie County and within the city of Avoca (2020 corporate limits) that is east and south of a line beginning at the north township line (also the north County line) and the northeast 2020 corporate limits of the city of Avoca (also known as 448th Street): thence southerly along the corporate limits to E Thomas Street, thence westerly along E Thomas Street to W Thomas Street, thence continuing westerly along W Thomas Street to N Walnut Street, thence southerly along N Walnut Street to W Wool Street, thence westerly along W Wool Street to N Pine Street, thence southerly along N Pine Street to W High Street, thence westerly along W High Street to the west 2020 corporate limits, thence southerly then easterly along the corporate limits to U.S. Highway 59, thence southerly along U.S. Highway 59 to the south township line; all of the area within Layton Township, Pottawattamie County that is south of a line beginning at the west township line and Teakwood Road: thence easterly along Teakwood Road to 515th Street, thence southerly along 515th Street to

State Highway 83, thence easterly along State Highway 83 to the east township line (also the east County line); all of the area within the school district in Lincoln Township, Pottawattamie County.

Director District 5: All the area within the school district in Monroe Township and Clay Township, Shelby County; all of the area within Layton Township, Pottawattamie County that is north of a line beginning at the west township line and Teakwood Road: thence easterly along Teakwood Road to 515th Street, thence southerly along 515th Street to State Highway 83, thence easterly along State Highway 83 to the east township line (also the east County line), includes the city of Walnut; all of the area within the school district in Cass County.
